

NRSB Continuing Education Credits Policy

The NRSB defines two different categories of Continuing Education (CE) Credits for our Certificate Holders that are renewing their certification:

- **Category I** includes traditional classroom lecture courses and hands-on courses, correspondence courses, video-based courses, and other types of distance learning courses. All courses must be NRSB-approved.
- **Category II** includes Symposium/Conference attendance, the presentation of technical papers, articles published in professional journals, public outreach presentations, instruction and technical service- In all cases it is recommended that the event/activity be submitted for approval and CE Credit allocation prior to the event's taking place.

Category I credits are likely to be given on an "hour for hour" basis, thus 1 CE Credit for each learning hour. Credits for **Category II** are normally given on a "1 for 2" basis, or 1 CE Credit for every 2 hours of attendance/participation.

For renewal purposes the NRSB has set the following guidelines:

- Irrespective of the category, all learning activities and/or events must have occurred during the current NRSB certification renewal cycle
- **Category II** CE credits cannot represent more than 50% of the total required Continuing Education credits for renewal
- The calculation of CE credits for **Category II** events/activities is as follows:
